

#### Reaction to Chase closure

THE news that The Chase Hotel in Ross-on-Wye is to close in September was greeted with sadness by many residents but there was also concern about the housing development which will replace the hotel

The company which owns The Chase told the *Ross Gazette* that they hope to have a detailed planning application ready be submitted to Herefordshire Council in the summer so that, consent permitting, redevelopment can start during the latter part of the year. Initial plans have been prepared which include building three blocks of apartments which will be around 100/120 apartments. Five detached houses will be built and the original house will be restored and converted into apartments. The scheme will include affordable housing, as well as properties for sale and rent.

A drop-in event at the hotel from 2pm to 8pm will take place on January 17th for anyone who would like to view the plans and comment. Camanoe also have a website www.consultingyou.co.uk/chasehotel if you are unable to attend, but wish to make comments online.

Many people responded to the breaking news on the Ross Gazette's Facebook page. Most remarked that it was sad news for the town but others recalled special family events such as weddings or large parties such as the annual John Kyrle High School prom. They also questioned where such events would take place in Ross in the future.

Sue Harding said: "Had our wedding reception 50 yrs past." Anne Wadeley added: "Such a shame the Chase has been part of Ross for so many years, but there you go it's a sign of the times unfortunately." Helen Rowberry said: "Aww no such a shame! We've had many functions there! Leavers ball, 25th wedding anniversary, birthdays, weddings xx" and Susan Wilding said: "Needs accessible bedrooms and a spa. Then it would be a great prospect for holidays, breaks and functions. Sad that it is being closed for redevelopment rather than sold as a going concern." Liz Wright said: "That's a shame. I guess the grounds will make huge profits for houses and the building for apartments. Takes the guts out of small towns."

#### Merrivale meeting

Dear Editor

Further to my letter in the *Ross Gazette* on Wednesday, January 9th, 2019, regarding the fact that a Town Council planning meeting was held on December 18th, 2018, two days prior to the due date people were requested to submit their comments on the Merrivale plans.

The kindest remark that could be said about it, is that it was a fiasco.

Even if the comments on the plans were not received until December 20th, there should still be a period

after that date to allow the public to inspect them before the meeting could be held. Whether it was the planning officer or the council members or both who arranged the date of the meeting, their action could not be seen as democratic and must be regarded as an error.

Surely because of this situation the whole thing should be deleted and declared void, and a new meeting be arranged as due democratic process was not permitted to occur.

No discussion was allowed on other items raised at the meeting, not least that the original application was for 22 houses.

Also, because of the opposition to the siting of the entrance to the site, a member of the planning team suggested it could be moved further down towards Alton Street. In my humble opinion, this would causes even greater congestion. Any further entrance from the site could cause more danger to children walking to and from schools up the lane adjacent to the site was raised and appeared to be accepted by the Chairman.

In my opinion any entrance onto the site from Merrivale Lane is not viable and consequently before any planning permission for houses to be granted the issue of the entrance should be resolved.

# Development divides opinion

DOZENS of local residents took the opportunity to view the plans the owners of The Chase Hotel have for the site, which they would like to see approved by Herfordshire Council later this year.

Many people were shocked when the news was broken by the *Ross Gazette* that the owners of the hotel, Camanoe Estates Limited, are to close it in September and are not intending to sell it to a company which would continue to run it as a hotel or function venue.

There was a huge amount of interest in the plans which were displayed at the Drop-in event on Thursday, January 17th. They showed the location for the five houses and three apartment blocks

in the grounds as well as the intention to leave the clos parkland and green space in the centre of the site man undeveloped.

In addition to Simon Porter, the company's accountants, architects and tree specialists were in attendance at the meeting to give their opinions on the development. Several people made it clear they were interested in the site as a future home or as a property investment. Many people were concerned about the trees and wildlife on the site but seemed reassured by the aboriculturist who stated that most of the trees would be untouched unless they needed maintenance.

One resident who lives close to the hotel, Linda Billinger, told the Ross Gazette, "The proximity of our property to the back of The Chase Hotel is

close, but we have a wonderful barrier of various mature trees which screens us from them and visa versa. What is going to happen to these trees was my main concern." She is very worried that the wildlife, including badgers, foxes, owls, and a large variety of other birds which will just disappear if this scheme goes ahead.

She added: "The scheme is a nonsense, and will just add more pressure on our already pressurised services" and appealed to the planning officers to: "listen to your residents and let's save this wonderful green space in our town, for our town, and come up with an alternative plan that benefit

#### Death in Broad Street

TRAFFIC in Broad Street, Ross-on-Wye, was brought to a standstill at about 5pm, on Friday, January 18th as emergency vehicles rushed to a flat where an unconsious man had been reported.

The West Midlands Ambulance Service told the *Ross Gazette* that they were called at 4.28pm and two ambulances and a paramedic officer attended. They discovered the patient, a man, was dead. They requested that the police attend the scene and several officers and vehicles were seen to arrive. One police vehicle had to drive on the pavement in New Street and the crew from an ambulance had to leave their vehicle in the road as they were unable to pass other traffic.

LINDSAY Wise, another local resident who has commented on the developer's own website, also contacted the *Gazette* to say: "The draft Ross Neighbourhood Development Plan reflects many views of the public and makes a great effort to balance the needs of housing and infrastructure development against retaining the character and the attractiveness of Ross as a town which people would want to visit. This proposal flies in the face of many of the statements made in the NDP. Even though it is still only in a draft form, I trust that the planning committee will take its proposals and findings into account and throw out this plan."

She added: "I appreciate that some

She added: "I appreciate that some development is probably inevitable on the site, given that the present owners are determined to close the hotel. I am appalled at the scale of what is being proposed. The impact of between 100 and 120 flats in three, three storey blocks as well as a few houses on the Gloucester Road side of the land will have a huge impact on the infrastructure and ecology of the area."

Other residents also mentioned the increase in traffic on Gloucester Road, as the access to the development will remain as it is at present. Many people are already concerned about the volume and speed of traffic which passes along this road and the neighbouring roads of Alton Street

and Chase Road and they told the Gazette they are worried about the extra traffic generated at peak times.

Constance Edwards, who lives on Alton Street, has also written a letter to the *Gazette* expressing her wish that the plans are rejected.



She said: "The Chase Hotel is the only large venue in Ross where important events can be held with many meetings, conferences, fairs and balls held there. The open space around the building also gives the people of Ross some respite from air and light pollution. The number of new residences that are proposed will add to these local problems."

Melvin Reynolds from the Neighbourhood Development Plan was at the consultation. He said that in the current draft plan for Ross, there are five houses on the Gloucester Road side and seven on the south side of the site. The new proposals are not included in the NDP and due to the time scales the hotel owners are hoping to achieve, it is unlikely that the NDP will be finalised before the proposal comes before the County planning committee.

Nicholas Tomlin commented on the Ross Gazette Facebook page: "Local residents are working hard to ensure their best interests - and those of the town are taken into consideration. Camanoe Estates can expect a well organised and strongly supported campaign against any development which is detrimental to the community."

#### **Grave concerns** about Chase site

WE are gravely concerned by the plans announced for the development of the historic Chase Hotel and surrounding land.

The Core Plan for Ross makes clear that this development must conform to the principles and policies contained in the national guidelines for Neighbourhood Development Planning. In particular, The Chase Hotel development must guarantee the protection, conservation and enhancement of a valued habitat including protected wildlife species in the Chase Hotel grounds (bats, small mammals and birds).

The local NDP plan requires that the development of the hotel must

ensure the continuation and sustainability of its open spaces and enhance their intrinsic character and attractiveness. The plan also mandates the development of, and investment in, infrastructure and amenities that will support the growth in quality tourism in this beautiful part of the Wye Valley.

The growing challenge from air pollution and carbon emissions will become more severe with the building of the planned 900 houses in and around Ross that has already been granted. The additional congestion and pollution would be particularly felt on the Gloucester Road, Chase Road and Alton Street quadrant, intensifying the increasingly dangerous traffic flows on Alton Street that are an ever-present threat to the health and well-being of pedestrians (older people and children especially) and nearby

Within the proposals, the plan to build three 3-storey buildings housing 110 residential units of a height no less than the main hotel building, together with the construction of underground parking, will be highly destructive to the surrounding neighbourhood. The loss of this precious green space within the town of Ross, the increasing noise, negative impact on wildlife, trees and shrubs and the pressures imposed on drainage, sewage and other infrastructure, will all greatly damage the well being of the local and nearby population.

The financial challenges for the owners of The Chase Hotel are real and serious but the proposals outlined highlight the overwhelming costs to both hotel and the community from the absence of a strategic plan to remedy inadequate, deteriorating infrastructure and the lack of an integrated vision and plan for Ross and its hotels, shops, housing, hospital, doctors surgeries and other important facilities, that will properly serve the growing population and increase the attractiveness of Ross to visitors.

#### Campaign to save the Chase Hotel

THE Mayor of Rosson-Wye, Harry Bramer, a Town and County Councillor, as well as a business man who owns and runs wedding venues, is calling on the owners of the Chase Hotel, Camanoe Estates Ltd to rethink their plans to close and redevelop the hotel site. And he wants residents who think that the Chase Hotel should be saved to join in him a campaign to persuade the owners to change their minds.

Councillor Bramer told the Ross Gazette that since this paper broke the news on January 9th that the Chase Hotel is to close in September 2019 his post bag has swelled with letters from local resi-

dents deeply concerned about the potential loss of the Hotel as a local valued asset.

He said: "To me and to those that have written to me – it is unthinkable that the Hotel be allowed to close – and as the Mayor of Ross – I consider it my duty to take exception with the current owners Camanoe Estates Limited when they say 'changing visitor preferences, coupled with high costs of upkeep have made it impossible to trade profitably'."

He added: "I would point out that these are my personal thoughts and not those of Herefordshire Council or its Cabinet or Ross Town Council where I am currently its Mayor."

The biggest concern raised was about the potential loss of the hotel as a locally valued facility. The next most common issue of concern was the impact of extra vehicles on local roads.

ment in favour of a second referendum); a vote on whether the UK should press ahead without a deal on the 13th; and a vote on a possible "limited extension" to Article 50 on the 14th.

There are too many different possibilities to explore here. But several things are clear. First, if it comes to it, Parliament as a whole is very likely to vote for some form of extension rather than allow a no-deal Brexit. Secondly, the different groupings opposed to the Withdrawal Agreement are having to recognise this political reality. If the Labour party is determined to scupper Brexit, it risks being severely punished by voters. Equally, no-deal Brexiteers are having to face the serious possibility that if they vote against, then Brexit may not take place at all. Thirdly, if there is genuine movement on the proposed backstop, then Parliament is likely

proposed backstop, then Parliament is likely to support the Withdrawal Agreement.

It is famously true of the EU that they never agree any deal until the very last moment. We are close to that point, so we must see what they have to offer.

My own view remains the same. The Withdrawal Agreement provides a sensible basis for a future long-term relationship with the EU, especially if the backstop is amended. And a second referendum, which in effect re-ran the vote in 2016, would be highly unwise. A no-deal Brexit would almost certainly be extremely painful in the short term. But the possibility of no-deal has very usefully focused minds both at home and in the EU.

As I have seen, it is highly unlikely that we would have seen the rapid recent improvement in Brexit preparations on the other side of the Channel without it. But the key point is surely this. People are

## Chase Hotel not in Town Plan

PLANS for development at The Chase Hotel almost derailed progress of the Neighbourhood Development Plan (NDP) for Ross-on-Wye.

Although the site was originally included in the NDP it was for a much lower housing allocation than the owners, Camanoe Estates Ltd, have revealed they intend to apply to Herefordshire Council for planning permission for.

Melvyn Reynolds, the Chair of Ross-on-Wye

Melvyn Reynolds, the Chair of Ross-on-Wye Town Council's Neighbourhood Plan Steering Group, told members of Ross Town Council that because the final stage of the Plan, which it is hoped to reached by autumn of this year, involves a Referendum, it was decided to remove the Chase Hotel and the surrounding land from the Plan.

The NDP, which will form the blueprint for future development in Ross, has now been passed to Herefordshire Council for their checks, before it goes out for the final consultation.

Mr Reynolds told the Councillors that originally the Steering Group decided to leave the Chase Hotel site, with the larger number of dwellings, in the Plan, but during February the group became aware 'that within the town there was considera-

ble disquiet about the proposals involving closure of The Chase Hotel.'

He explained: "Because the final stage of the NDP approval process involves a Referendum (approve the Plan – or not) it was judged that the risks of overall failure were too great if the site is included. This decision was reached in spite of rehearing the risks of the Plan being silent about the site. The plan submitted to Herefordshire Council therefore makes no mention of The Chase Hotel or the surrounding land."

After the next consultation all comments will again be addressed, after which the NDP is submitted for Examination by an external planning expert; again any requests for changes must be made. After which the final Plan enters the pre-referendum period of a further six weeks. Depending how many comments are made through those processes the Referendum is now expected in early autumn 2019.

Councillor Nigel Gibbs said: "It is regrettable that there have had to be last minute changes, but

the Plan does give a vision for the future of Ross." The Town Council voted to accept the plan.

Also at the Town Council meeting a member of the public, Caroline Hopkins, asked for clarification about the wording of the petition which is being circulated around the town.

The Mayor passed around a copy of the petition, which asks people to sign if they believe the Chase Hotel should be saved from redevelopment as flats but should remain as an hotel and an asset to Ross.

Another member of the public, Joyce Thomas, who has been collecting signatures on the petition, asked the Town Councillors if they would say whether they back the development or not. She said a lot of residents feel very strongly abut the Chase and it has been a focal point to many occasions enjoyed by local people.

Councillor Jane Roberts said: "We cannot preempt the decision making process by giving an opinion before an application has been made and is discussed by the Council."

#### Stopping Chase plans

JOYCE Thomas and Marie Ward were out and about in Ross-on-Wye on Thursday, February 28th, gathering support for Councillor Harry Bramer's campaign to protect The Chase Hotel from redevelopment. In an hour, they received 149 signatures.

Councillor Harry Bramer told the Ross Gazette: "I am at a loss to understand the proposed closure of the Chase Hotel for the reasons stated by the directors of Camanoe Estates Limited, namely, the change in customer preferences and the high cost of running the business."

The Chase Hotel accounts filed are non audited and are abbreviated; a balance sheet shows that the company was incorporated in 1962. Councillor Bramer said that the last accounts filed were to March 31st, 2018 and a loss was made of £60,000 after depreciation of £51,000. Thus, the loss prior to depreciation was £9000. Its net assets were £3.4m, consisting of freehold property of £1.4m, and investment property of £470,000 and a loan to a connected company (Alan Porter Ltd) of £1.4m.

Councillor Bramer said: "In summary, the company, with a loss of just £9000, is perfectly viable and the company is certainly asset rich. Having looked at this publicly available information I can see no justification for closing the hotel."

Councillor Bramer set up an online petition on Monday, March 11th to continue the effort to save The Chase Hotel from redevelopment. A LEAFLET came through my door the other day, mostly using the phrase 'we demand'. Odd phrase to use if seeking change from power. It is my experience that appeals are better conducted

via rational argument that gains popular support, culminating in a request hard to resist. Or, failing this, using elections and hustings preceding them to discuss and persuade in a civilised manner.

Screeching until you turn blue, or red, or green on the spot appears the new black and white. It shouldn't work, but often does, mainly because of the calibre of those supposedly in positions of leadership, who will always opt for the easy option, and to avoid getting ears bashed is to concede to those making the most noise.

Also, to maintain using draconian antics exploiting supposedly well-meaning and too often vague new legislation in the hands of those more comfy with the letter than spirit of laws.

And a media estate consumed by 'human interest' at best, and heat over light ratings at less ethical. One such that concerns me greatly is the use of the young, either as rallying icons or, more cynically, as direct advocacy figureheads on the soapbox.

Who could, or would dare to challenge a child? Well, where necessary, the young do need to be met on equal terms, especially when there is a suspicion their youth is a front for those less young but with much older agendas.

I have some unpleasant experience with this having been advised by my kids' pragmatic teachers that a woefully inaccurate AQA text was best addressed on two competing fronts: a) to pass the exam, b) to actually be educated accurately in class in tandem to compete well informed in a global market. Wasteful and unfair.

I have a science and engineering background enough to look at facts objectively, or at least in a way to seek out and assess more trustworthy expert input. I also worked in the field of advertising and marketing long enough to be able to see an agenda being pushed over when substance is lacking. And having experienced parenthood with toddlers, youth, teens and young adults long enough to see what wonders can be worked when healthy minds are applied and sensibly guided.

'Rebellion' has connotations that make my historical antennae twitch, especially as words from past eras make an unwelcome return, to push agendas and suppress or censor counter view. Of course debates can and should thrive at all times, but on matters of policy, elections every few years

is where they get resolved democratically. I have personal doubts on the value of endless petitions, marches, polls, etc, but they are part of a long history of free speech and form all that goes into democratic process.

More positively, as I tour and present at schools and colleges, it is a privilege and inspiration to see young minds grasp what is possible and get motivated to take promising avenues further forward, by doing productive, innovative stuff. These are who will build their own future and take ownership of it. Simply shouting the odds and waving lazy banners comes across as the preserve of the bitter and failed bully sector, with sheep dutifully tagging along. These are my views and may be agreed with, ignored or challenged.

#### Concerns that The Chase Hotel cannot be protected

AT Ross Town Council's Annual Review Meeting on Monday, April 29th, Chairman of the Neighbourhood Development Plan (NDP), Melvin Reynolds, gave a presentation about the NDP and explained why allocating The Chase Hotel as a Local Green Space would not necessarily protect it from redevelopment.

Melvin said: "NDPs are mechanisms which

devolve certain levels of planning responsibility to communities. They are outlined by national planning policy framework. The basis of Rosson-Wye's NDP came out in 2011, and was finally ratified in 2013-14. Herefordshire has number of NDPs, and most of them are based around

Many of the residents who attended the meeting were concerned the find out that The Chase Hotel has not been allocated in the NDP, which is now in its final stages. The draft plan is now being adjusted based on consultations and discussions, and Melvin anticipated that it would be put forward to local residents for a referendum in late Autumn, 2019.

Melvin said: "Following consideration and exclusion of proposals brought under Regulation 14, The Chase Hotel has been excluded from the NDP as a Local Green Space and a development

The advice that the NDP team have been given is that there 'is no question at all' that any attempt to designate all of the 'green' area as a Local Green Space would fail at examination. This would be regarded by any planning examiner as 'preventing potential development'.

One option advised to those working on the NDP was to designate only a part of The Chase Hotel as a Local Green Space, although, Melvin warned that even that could be regarded by an examiner as too restricting, and comments from

the landowner would be anticipated.

Another option would be to add a new policy to the current NDP. There are already policies in the Plan about historic parks and gardens and about retaining what is termed 'green infrastructure'. To achieve such a policy, evidence would need to be sought with consultations, involving site neighbours and others, to provide an opportunity to explain the legal situation clearly to everybody.

A further option suggested by advisors was to await imminent revision of Herefordshire's Local Plan so that it could include a policy similar the previous one, in response to consultations.

Melvin displayed examples of planning drawings for The Chase Hotel that have been considered before to help illustrate the variations in green spaces and housing allocation. These included considerations of housing developments, a spa, or holiday lodges.

Melvin presented four options at the meeting: Leave the NDP as it is; consult on Local Green Space; consult on an extended Green infrastructure policy to apply to The Chase; await imminent revision of the Local Plan to include a county-wide policy similar a Green Infrastructure policy. He also invited suggestions from those at the meeting, and said that the plan for The Chase was

hoped to be finalised by December 2019.

Joyce Thomas MBE thanked Melvin for his work on the NDP but said that she was 'disappointed' with the fact that The Chase had been excluded from the NDP. She said: "The Chase Hotel is of immense importance. Three of us, Mayor Harry Bramer Marie Ward, and L without Mayor Harry Bramer, Marie Ward, and I, without any trouble, have had over 1000 signatures hoping to protect The Chase."

Councillor Bramer explained that the NDP was

well into development until early January when it was announced that The Chase Hotel would close. He said since then the Plan has been in 'disarray'.

Councillor Hannah Lerego wanted to clarify

that currently, the Town Council has no official view regarding The Chase Hotel. She said: "I have lived here since 2000 and think The Chase Hotel is great, but I would like to say that there's no official Ross Town Council view on whether it should be saved.

"Nobody can speak for us collectively; this is an emotive issue but the Town Council are not telling the owners of The Chase what they should or shouldn't do. The NDP has had a huge amount of research and it's clear why The Chase Hotel has


been left out - it's because otherwise it would fail.

One resident asked if the Town Council could have a view on this issue, to which Councillor Bramer replied 'absolutely'. He said: "I have put forward a motion for the next Town Council meeting. My view is that there has been an omission and this should be put right, and the NDP should be advised of Town Council's wish to do this. It is up to the next Town Council to vote on that, and that is what will become the Town Council's official view.

Melvin said: "This just adds to the view that somehow we need to work through this. If a Local Green Space is what we want then that's fine, but we need to find a way of putting it forward in a way that isn't trying to stop future development that is problematic, and that will fail."

He then asked for a vote about which option should be chosen. Some residents expressed their anger at being asked to choose between options they still did not understand. In the end, it was decided that the options would not be narrowed down at this stage, and allocating The Chase Hotel as a Local Green Space was not ruled out. Despite this, Melvin warned that it was very unlikely that The Chase Hotel could be allocated just as Local

Green Space because of the planning regulations.
At the end of the meeting, residents had the chance to discuss the NDP and the situation regarding The Chase Hotel further with Mayor Harry Bramer, Melvin, and other Town Coun-

FORMER Mayor and Councillor, Harry Bramer, put forward a motion for the new Town Council to vote on at the Annual Meeting of the Full Town Council on Monday, May

Harry told the Ross Gazette: "There is growing concern in the Town that The Chase Hotel was missed out by the Town Council for designation as Local Green Space in their submission to Herefordshire Council for the Neighbourhood Development Plan.
"I intend to correct this error at the

first opportunity."

It read that 'this Town Council notes that the land at The Chase Hotel was not considered for designation as a Local Green Space during the preparation of the Neighbourhood Development Plan and supports the immediate consideration of the grounds below the car park down

to Waterside as a designated site.'
In addition, it advised than 'an application be made to register The Chase Hotel, its entrance drive, car park, and gardens as an Asset of Community Value.

Councillor Julian Utting proposed

an amendment to the motion, and Councillor David Ravenscroft seconded the motion.

Councillor Utting said: "This Council recognises the controversy within the town about proposals for future development of The Chase Hotel site. The Council also recognises its responsibilities as a statutory consultee and the obligation not to take a position on any planning issue in advance of a formal application.'

His motion read that as an elected body and as individuals, the Town Council have no pre-determined opinion in respect of future planning applications on The Chase Hotel site, and acknowldged full confidence in the Neighbourhood Plan Steering Group to develop appropriate planning policies in respect of The Chase Hotel site.

The motion also stated that the Town Council would delegate to the Planning Committee to investigate and recommend back to the Full Council the appropriateness of including The Chase on the commu-

nity asset register.

Apart from Councillor Katie Fowler who could not participate in discussions regarding The Chase, the Council voted unanimously to amend the motion.
