Cemetery Fees as from 1st April 2026

Part 1: PURCHASE OF GRAVE SPACE

GRAVE SPACE FOR INTERMENT OF UP TO TWO BODIES	£520
GRAVE SPACE FOR INTERMENT OF A BODY OF A CHILD UNDER THE AGE OF 18 YEARS	£175.00*
* this fee would be applied for from the Children's Funeral Fund through the Government, so that there would be no cost to the parents or family of the child.	
GRAVE SPACE FOR INTERMENT OF ASHES	£250.00

Part 2: INTERMENTS

Interments in a grave in respect of which an exclusive right of burial has been granted in a specified earthen grave for up to 50 years. The interment fee includes the digging of the grave.

1) OF A BODY OF A CHILD UNDER THE AGE OF 18 YEARS AT THE TIME OF DEATH	£380.00*
* this fee would be applied for from the Children's Funeral Fund through the Government, so that there would be no cost to the parents or family of the child.	
2) FOR THE INTERMENT OF A BODY OF A PERSON WHOSE AGE AT THE TIME OF DEATH WAS 18 YEARS OR OVER	£1080.00
3) TO REOPEN A GRAVE FOR A SECOND INTERMENT OF A BODY OF A PERSON WHOSE AGE AT THE TIME OF DEATH WAS 18 OR OVER	£1000.00
4) FOR THE INTERMENT OF CREMATED REMAINS	£250.00

Part 3: MONUMENTS

The following are fees for the installation of memorials on a grave space for which exclusive rights of burial have been granted. Please see Cemetery Regulations for restrictions on monuments.

1) SMALL VASE NOT EXCEEDING 12" X 8" X 8"	£100.00
2) TABLETS ERECTED HORIZONTALLY OR VERTICALLY AND NOT EXCEEDING 21" X 21" COMMEMORATING PERSONS CREMATED	£100.00
3) ANY OTHER MONUMENT WHICH MUST NOT EXCEED 3ft 6 ins IN HEIGHT	£250.00
4) ADDITIONAL INSCRIPTION ON EXISTING MONUMENT	£80.00
5) KERB STONES	£450.00
6) FULL KERBSET (INCLUDING HEADSTONE)	£650.00

Part 4: OTHER FEES

1) TRANSFER OF EXCLUSIVE RIGHTS	£100.00

The above fees and charges do not include any sums payable to ministers for funeral services, nor to funeral directors for arrangements, or payable to monumental masons for the provision of headstone/memorials.

**The above fees apply to all persons who are parishioners of the Town of Ross-on-Wye at the time of death.
For all other persons all fees will be doubled. Transfer of Exclusive Rights to non-parishioners will incur the additional fee.**
